Mrs. Gist presented the FY 2023-2024 General Fund and Debt Service Budgets for approval as final reading.

*Ms. Smith made the motion to approve the FY 2023-2024 General Fund and Debt Service Budgets, which was duly seconded and approved 5-0.

Mrs. Gist presented for approval a resolution to sell up to \$7.9M in general obligation bonds to be used to finance maintenance and capital projects and to maintain and upgrade technology throughout the district.

*Mr. McKillop made the motion to approve the annual debt resolution, which was duly seconded and carried 5-0.

Mr. Acosta shared good news happening in the District, including our recent graduations at Boiling Springs High and Chesnee High, Player of the Year accomplishments, and refreshing our schools' webpages.
